JOIN HANDS DAY

It starts with US!

oin Hands Day is the only national volunteer day that specifically targets and develops relationships between young people and adults through neighborhood volunteering. Youth and adults work together on an equal basis to plan, organize and implement the day's activities.

We know many of you would like for your branch to participate in this day of service but aren't sure what to do. This is where trust in our youth comes in. It is very important to include a youth group in the decision of what to do for a project. If they are into it, the project will be much more successful and fun. Having said that, it is a good idea to be able to throw out some ideas for a project.

Now, we know some branches have few youth members, and even if they do have youth members, many are too young to do a project like this. That is a legitimate concern. However, we all know some school-aged kids; whether it is through your church, a Boy Scout or Girl Scout troop or other youth organization. Finding a youth group to partner with is not that difficult but is one of the first steps you need to take in putting on a Join Hands Day project.

So, how do you plan a project? Here are the steps you need to take:

- **I. Start a Join Hands Day Committee.** Establish a Join Hands Day Committee and designate a project leader for your branch. Be sure your committee chair keeps track of your hours and number of members/volunteers involved.
- **2. Identify a Youth Group to Partner With.** As stated above, identifying a youth group to work on the project with your branch is very important. Once you have established that, the rest will come naturally.
- **3.** Choose a Project. It is important to include the youth in the decision process of choosing a project. Let the group brainstorm on project ideas and have some ideas of your own to throw into the mix. Age of the youth, age of the adults and abilities and physical limitations of both all play a role in what project your group is best suited for.
- **4. Planning.** Get together with your youth group to solidify the project and put together a list of resources or supplies that will be needed for the project or if there are other projects the group needs to do ahead of time to get ready for the Join Hands Day event. Identify individual members to be responsible for securing the items needed. Decide the time of day and amount of time needed to do the project or any project preparations. Announce the project at your branch meeting and recruit members to help with the project.
- **5. Nail Down the Details.** Get the group together one last time to nail down the details and make sure everything is in place to make the project successful. Define

specific tasks to be completed. Identify a member to take pictures during the event and of the group.

6. JOIN HANDS DAY, MAY 6, 2017!

7. Report Your Project to the Home Office. Obviously, we want to hear about your project and get the pictures to be able to use in *William Penn Life* and on our website. It's a fraternal story that writes itself!

That to do can be very intimidating and a tough hurdle to get over initially. The age of the youth, age of the adults and the abilities and physical limitations of both are important when deciding on a project. Below are some simple project ideas that may be suitable for your project. When you are brainstorming ideas, be sure to throw out some of these to the group. Or, if one of these projects hits your fancy, select that project and then find a youth group to help with that specific project. It does take the youth out of the decision-making for what project to do, but you can include them in the planning meetings for the event.

- Have a food drive scavenger hunt.
- Prepare sandwiches and personal care kits for the homeless.
 - Have a backpack/school supply drive.
- Have a spring clean up day in a park or do some yard work for the elderly or someone with physical limitations.
 - Make May baskets for the elderly.
- Plant flowers, shrubs, trees and/or plants in a park or at a nursing or group home.
- Rent or borrow Wii consoles and video games and take to a nursing home for youth and residents to play Wii games.

Regardless of what you decide to do for a Join Hands Day project, please remember to report it to the Home Office and make sure you take pictures throughout the process.

Power of Attorney

WELCOME SPRING! I don't know how the winter was in your neck of the woods, but here at the Home Office in Pittsburgh, we were fortunate to avoid any major weather issues this winter. I'm looking forward to hitting the road again, visiting our agencies across the country and supporting the many street fairs and events that spring and summer bring.

In the course of my travels, members and agents often ask about the benefits of having a power of attorney as well as the different types that are available. While we can't give legal advice, I did some research and can provide the following as a general overview of the basics of the power of attorney and the impact it can have on your estate plan.

What is "Power of Attorney?"

A power of attorney (or POA) is a document that enables an individual to appoint a person or organization to manage their affairs should the individual become unable to do so themselves. According to the National Caregivers Library, a POA is granted to an "attorney-in-fact" or "agent" to give that person legal authority to make decisions for the person granting the power, also known as the "principal." Laws for creating a POA can vary by state, but there are some general similarities regardless of the principal's domicile.

Why is a Power of Attorney needed?

Many people believe that their family members (siblings, children, etc.) will be able to automatically step in on their behalf should they become incapacitated and unable to make decisions for themselves. Unfortunately, this is not always the case. If you do not name someone as your agent or attorney-in-fact, your family may not have access to your financial, medical and other important information. In addition, the government may step in and appoint someone to make certain decisions for you if you have not named an agent.

Who can benefit from having a Power of Attorney?

Just about everyone can benefit from establishing a power of attorney and appointing an attorney-in-fact. Doing so does not mean that you cannot live independently, but it will remove the legal barriers if you would happen to become physically or mentally incapable of managing certain tasks. Oftentimes, these events occur very quickly, making the appointment of the attorney-in-fact very difficult once incapacitated.

What are the different types of Power of Attorney?

Power of Attorney is a general term that covers various aspects and levels of decision making. The main types of POA include "general powers, healthcare powers, durable powers and special powers of attorney." Many of the responsibilities overlap, but there are some legal differences



to be aware of. Durable Power of Attorney, for example, relates to *all* the appointments involved in general, special and healthcare Powers of Attorney – thus, making it more "durable." This means that the document will remain in effect, or take effect, if a person becomes mentally incompetent. Certain powers of attorney may fall within a certain time period as well, so it's best to consult with an attorney to see which might be best for your situation.

What is covered under a Power of Attorney?


An agent appointed as attorney-in-fact may be able to handle the following, or more, depending on the wording of the POA document:

- Banking transactions
- Buying or selling personal or real estate property
- Settling claims
- Filing tax returns
- Managing health or government benefits
- Maintaining or running of a business
- Making estate planning decisions
- Deciding on medical treatments
- Fulfilling your health care directives

Although a Power of Attorney can be filed and an agent appointed on one's own, we suggest working with an attorney or estate planning team to get a better understanding of your options and the intricacies involved with the various POA documents.

Life is full of unexpected twists and turns. Just because the future is unpredictable does not mean that you can't prepare for what lies ahead. Like life insurance, estate planning is important and establishing the correct Power of Attorney can be essential for members looking to protect their financial resources, assets and most importantly, their loved ones.

The story of 'Gloomy Sunday

IN THE FEBRUARY 2017 Tibor's Take, I discussed the production of Hungarian 78 RPM records. Soon afterwards, a gentleman named Louis from the San Francisco area emailed me an informative response. We exchanged messages, and eventually he sent me several high quality photographs concerning a specific song, composer and lyricist. An intriguing story emerged of how a simple song of sorrowful lament became an international musical sensation.

There are certain songs that every quality Hungarian band can perform. Songs such as "Az a Szép," "Csak Egy Kislány" or Rhapsody #2 by Liszt are standard selections of a band's playlist, but

one particular song is usually performed only if requested

specifically by a patron.

I had the opportunity to hear live versions of "Szomorú Vasárnap" ("Gloomy Sunday") on two occasions while visiting Budapest in 2014 (at two restaurants, Százéves and Mátyás Pince). Although I have played recordings of the song on our family's Hungarian radio program, it was not until recently that I realized the peculiar and morbid history of this composition surfaced. So, without further ado, I present the story of "Gloomy Sunday."

Rudolf Spitzer was born on Nov. 3, 1889, in a poor, working-class area of Budapest. During his early years, the city was going through an extensive building boom that made for an exciting and happy childhood. He spent his teenage years working in theater and in small circus venues, eventually becoming an acrobat and trapeze performer. Along the way, he taught himself to play the piano and performed in various bars.

Facing discrimination, Spitzer changed his name to Rezső Seress, but his career was abruptly altered due to a serious accident that occurred during a practice session which caused him to lose motor function in one of his hands. So, Seress concentrated on learning to play the piano with just five fingers and focused on composing and singing.

Meanwhile, the world was heading towards The Great Depression of the 1930s. Sandwiched between two world wars, the era was one of near seamless despair that persisted for a generation. The "Great War" produced a worldwide economic collapse, creating great suffering throughout Europe. Hungary had the dubious distinction of being aligned on the side that lost both world wars. These overarching political and economic circumstances made daily life bitter, hard and difficult. It was in this context that Seress found inspiration for his art.



For a short time Seress lived and worked in Paris (1932-33). This was where he devised the original melody and lyrics to a song titled, "Vége a Világnak." ("End of the World"). The inspiration for this tune was a recently failed romance. Upon returning to Hungary, Seress confided the details of this romance and shared his sorrow and song with dear friend and gifted poet László Jávor (1903-1956). Coincidentally, Jávor had just broken up with his longtime girlfriend, and he and Seress shared a common grief and anguish. As the two mulled over the recently devised composition, Jávor offered to revise the lyrics and, just like peanut butter and

jelly or paprika and szallona, a perfect match of music coupled with words was created. The name of the tune was revised as well: "Szomorú Vasárnap."

Szomorú vasárnap száz fehér virággal Vártalak kedvesem templomi imával Álmokat kergető vasárnap délelőtt Bánatom hintaja nélküled visszajött Azóta szomorú mindig a vasárnap Könny csak az italom kenyerem a bánat...

Szomorú vasárnap

Utolsó vasárnap kedvesem gyere el Pap is lesz, koporsó, ravatal, gyászlepel Akkor is virág vár, virág és - koporsó Virágos fák alatt utam az utolsó Nyitva lesz szemem hogy még egyszer lássalak Ne félj a szememtől holtan is áldalak...

The song became an instant hit within the city. The famous Hungarian actor and vocalist Jávor Pál contacted Seress and expressed an interest in publishing sheet music and an audio recording of the three-verse dirge. For the first time in his life, Seress had some money and good fortune. In 1934, he married Hani Nadler (1901-1969). It is unclear if Nadler was the same person the song was written about.

"Gloomy Sunday" immediately became the stuff of urban legend as it was purported to have inspired dozens of suicides in Budapest and surrounding areas of Hungary. The Danube and Tisza Rivers, as well as Lake Balaton, became popular sites for suicides, with some blaming the deaths on the song, although most likely the suicides were simply the sad result of widespread poverty and famine.

Some believe that Jávor Pál sold the music to an American promoter in an unauthorized manner during one of his many musical tours to the various American-Magyar communities. In 1936, Ray M. Lewis translated the lyrics into English, and the Hal Kemp Orchestra recorded what is believed to be the first English version of the song. That was followed by recordings made by Paul Robeson, Billie Eckstein and Luis Russell. Perhaps the best known English version was sung by Billie Holiday:

Sunday is gloomy / My hours are slumberless.

Dearest, the shadows / I live with are numberless.

Little white flowers / Will never awaken you.

Not where the black coach / Of sorrow has taken you.

Angels have no thought / Of ever returning you.

Would they be angry / If I thought of joining you?

Gloomy Sunday

Gloomy is Sunday / With shadows I spend it all. My heart and I, have / Decided to end it all. Soon there'll be candles / And prayers that are said, I know. Let them not weep / Let them know that I'm glad to go. Death is no dream / For in death I'm caressing you. With the last breath of my soul / I'll be blessin' you.

Gloomy Sunday

Dreaming, I was only dreaming / I wake and I find you asleep In the deep of my heart, dear.

Darling, I hope that / My dream never haunted you. My heart is telling you / How much I wanted you.

The song became popular in England at the same time a rash of suicides occurred on both sides of the Atlantic as the song grew in prominence.

The BBC banned public airing of sung versions of "Gloomy Sunday" believing it detrimental to wartime morale, although it did allow instrumental versions to be aired. The ban lasted until 2002, and many radio stations here in the United States did the same type of censoring.

Seress loved his simple life in Budapest and did not benefit from royalties generated outside of the borders of Hungary. He could have made a small fortune from the many recordings that were made here in America, but he chose to remain in Hungary instead of pursuing his compensation through the U.S. court system.

Unfortunately, Seress was forced to spend several years in a concentration camp during WWII. It is said that he survived those horrible times by utilizing his notoriety as an entertainer and the author of "Gloomy Sunday," which was quite popular in pre-WWII Germany. He became a useful commodity for the Nazis, performing in a style similar to that depicted in screenplays such as the Emmy award-winning movie "Playing for Time."

Once the war was over, he returned to Budapest with his wife and became the house musician at a small establishment named the Kispipa Vendéglő on 38 Akácfa utca, which until recently remained open for business.

Seress became a member of the Hungarian Communist Party and composed a popular propaganda song entitled "Újra a Lánchídon" ("On the Chain Bridge Again"), as well as a few other compositions that attained minor acclaim, "Waiter Bring Me the Bill" and "I Love Being Drunk."

More recently recorded versions of "The Hungarian Suicide Song" have been done by such notables as Ray Charles, Sarah Vaughan, Elvis Costello and Sinead O'Connor. In the late 1950s, Ricky Nelson made a recording of the Seress tune, but it is said that his father Ozzie prohibited him from issuing the record. Ozzie felt the clean-cut image of the Nelson family would be tarnished should Ricky's teenaged female fans follow the example of so many listeners of this song and do the unthinkable.

Other songs have been written supposedly prompting suicide, but most pale in comparison to the number of tragedies ascribed to "Gloomy Sunday." László Jávor regretted having ever revised the lyrics to this tune as the press depicted him as a notorious villain responsible for ending many lives.

Several Magyar bands have recorded "Szomorú Vasárnap," including Kalman Lendvay, Sándor Lakatos, Gyula Horváth, Vilmos Lakatos, László Berki as well as singers Sári Barabás and Antal Kóczé. One movie has been made vaguely portraying Seress and László Jávor and was appropriately titled "Gloomy Sunday."

Seress and his wife lived for over 20 years in the same small, second-floor apartment at 46 Dob utca in District VII. In 1968, Seress attempted to kill himself by jumping out a window from that very apartment. While recovering at a nearby hospital, Seress attempted suicide again, this time successfully by hanging himself in the doorway of his room. Prior to his self-imposed demise, Seress stated: "I am so very sad to have not made another hit song like 'Gloomy Sunday.'" His wife Hani died in 1969.

There are many Magyar *halgatos* portraying tragic scenarios, such as the popular "A Vén Cigány," but "Szomorú Vasárnap" is by far one of the saddest musical commentaries of all time.

The song surfaced at the right time as the circumstances of economic despair along with an impending war aided in forming an exquisite match of sorrow to song.

CLEVELAND -- The Cleveland Hungarian Development Panel (CHDP) hosted its 27th annual Paprika! Bál on Saturday, March 4, at the Ritz Carlton Hotel in Cleveland.

Desserts included Dobos Tortes, Krémes, miniature Hungarian *fánk* (donuts cooked to order) and fresh fruits.

The entertainment was provided by Harmonia and the Viva Dance Studio whose ballroom dancers performed several waltzes and tangos.

Actuary's Report for 2016

WPA members should be very proud of the Association and its financial strength

William Penn Association continues its long history of outstanding service to members while maintaining an increasingly strong margin of safety for members, with an emphasis on member guaranteed benefit contracts.

Certain highlights from the financial reports to the regulatory authorities and the actuarial report to the Officers and Directors should be summarized for the benefit of the members. All numbers herein are taken from the official reports as filed. References are rounded for convenience.

Emphasis in 2016 was, again, on controlled growth and development. The program has been proven to be eminently successful. Assets increased by 9%, while premium income increased to \$44,835,000. At the same time, profits before dividends increased to \$2,303,000. These profits are attributable to careful management of investments, favorable persistency and favorable mortality experience.

The year 2016 continued the Association's long history of returning to the members the highest possible benefits consistent with safety. The major lines of business were again profitable. This is a fine record. The members should feel very proud of WPA and its financial strength to guarantee their benefits. WPA continues its emphasis on safety

The strong financial position of WPA should be emphasized. In its history, no WPA member suffered any loss in

benefit value or reduction in dividends nor experienced a rate increase because of market fluctuations. WPA continues to be a very safe, secure place to hold money for future delivery.

Assets at over \$411,000,000 continue to be valued very conservatively, are of exceptionally high quality and fully comply with the strict standards of the National Association of Insurance Commissioners (NAIC). All members can continue to have confidence that the assets standing behind their policies are sound and will provide the required funds when needed.

The safety margin on December 31, 2016 continued at the very high level of 108%. This means that the Association held over \$108 of admissible assets behind each \$100 of liabilities as a safeguard and guarantee to all members that the benefits promised in the certificates will be paid when due. The Association enjoys a stronger safety margin than most of the very large companies. This strong safety margin will continue for the benefit of all members, even into the next generation.

The Association enjoyed a very favorable year from investments. The net rate of return on mean assets was 5.38%, which supports the generous rates paid to members. During 2016, the Association earned net investment income of \$20,677,000 after deducting all investment expenses. Investment income exceeded requirements by

\$8,210,000 in 2016. Excess interest continued to be the most important profit source to the Association.

In addition to the excellent investment returns, it is worth noting that the Association maintained its Security Valuation Reserves, to guard against adverse fluctuation in investments, at \$4,148,000. The members' assets are well protected by this strong safety fund.

The Association has set aside \$376,284,000 of life, annuity and A&H reserves, deposits and claims for future payments to members. Management continues its prudent and conservative practice of setting aside sufficient funds with which to meet all known and contingent liabilities. William Penn Association is doing an outstanding job of managing the members' funds.

An important index of service to members is the total amount paid to members. During 2016 the Association paid the significant amount of \$26,121,000. A summary of these payments to members for the past two years is as follows:

WPA continues to render a truly valuable financial service to members.

In our opinion, the amounts carried in the balance sheets on account of the various actuarial items:

- (1) are computed in accordance with commonly accepted actuarial standards consistently applied and are fairly stated in accordance with sound actuarial principles;
- (2) are based on actuarial assumptions which produce reserves at least as great as those called for in any contract provision as to reserve basis and method, and are in accordance with all other contract provisions;
- (3) meet the requirements of the insurance laws and regulations of the Commonwealth of Pennsylvania and are at least as great as the minimum aggregate amounts required by the state in which this statement is filed;
- (4) are computed on the basis of assumptions consistent with those used in computing the corresponding items in the annual statement of the preceding year end with any exceptions as noted below; and
- (5) include provision for all actuarial reserves and related statement items which ought to be established.

It is apparent that the officers and directors continue the skillful management of the members' money while maintaining very strong safeguards.

The Board of Directors has established the following rules governing eligibility for scholarship recipients:

- c) Scholarship grants are awarded to full-time undergraduate students only if they have been accepted by or are currently attending an accredited college, university or school of nursing.
 - d) Grants are awarded for a two- or four-year period.
 - e) New applicants must submit the following:
- I. WPFA Scholarship Foundation, Inc., Application for Scholarship Grant, which can be found in this issue of William Penn Life. An application also may be obtained by writing to: President, William Penn Fraternal Association Scholarship Foundation, Inc., 709 Brighton Road, Pittsburgh, PA 15233, or may be downloaded from the Association's website at www.wpalife.org.
- 2. An Essay of 100 words or fewer answering the question: "With all of the societal problems we face today, where do you see goodness in the world?" If the essay exeeds 100 words, the student's application will not be accepted.

The Scholarship Application and Essay must be mailed and postmarked by Wednesday, May 31, 2017. We recommend the student submit these materials via Certified Mail to ascertain proof of mailing date.

- 3. A transcript of the student's latest high school scholastic record.
- 4. Proof of enrollment for the Fall 2017 school term.

Items 3 and 4 must be mailed and postmarked by Friday, September 15, 2017.

- f) Renewal applicants must submit the following:
- I. WPFA Scholarship Foundation, Inc., Application for Scholarship Grant, which can be found in this issue of *William Penn Life*. An application also may be obtained by writing to: President, William Penn Fraternal Association Scholarship Foundation, Inc., 709 Brighton Road, Pittsburgh, PA 15233, or may be downloaded from the Association's website at www.wpalife.org.
- 2. An Essay of 100 words or fewer answering the question: "If you were applying for an internship at William Penn Association, how would you convince us that you are the right person?" If the essay exeeds 100 words, the student's application will not be accepted.
- 3. A copy of the student's latest scholastic record. All renewal applicants must maintain a cumulative Grade Point Average of at least 2.5 on a 4.0 scale to qualify.
 - 4. Proof of enrollment for the Fall 2017 school term.

Items 3 and 4 must be mailed and postmarked by Friday, September 15, 2017.

- g) All applications and essays must be submitted and signed by the student requesting the grant and mailed to the attention of the President. Eligibility rules for renewal grants will be in accordance with the eligibility rules in effect for the initial grant. Materials submitted by anyone other than the student will not be considered. **E-mailed submissions will NOT be accepted.**
- h) Scholarship grants will be awarded by the Executive Committee of the William Penn Fraternal Association Scholarship Foundation, Inc., once each year. Grants will be paid directly to the applicant provided the student is a life benefit member in good standing on the date the check is issued and all of the eligibility requirements stated herein have been met.
- i) If for any reason the recipient does not attend college after receiving the grant, it must be returned to the William Penn Fraternal Association Scholarship Foundation, Inc.
- j) In compliance with current privacy laws, all information in regards to the scholarship status will be divulged only to the applicant/student.
- k) All applications and essays must be mailed and postmarked by **Wednesday, May 31, 2017**. Any applications and essays postmarked after that date will not be considered.

Aging Well with Cathy Graham

Feeling 'dad-sad'

IT HAPPENED ON AUG. 4, 2016, and still I can barely bring myself to type the words, let alone say them out loud: My dad passed away at 79.

Nothing, it seems, could have prepared me, and nothing, it seems, will repair me. It's not getting easier, nor is it getting smaller. It is quite the opposite. The sadness is thicker and heavier and paralyzes me when I am still.

His death seemed more appropriate in August. He was no longer trapped in a body that failed to serve him or attached to machines that greatly annoyed him.

My dad was my one true thing. I was his shadow growing up, and we maintained that closeness until he passed. My teenage years, college years and single parent years tightened our bond, no matter the distance.

In the advance stages of his illness I wanted nothing more than to take his cancer on and beat it with my bare hands. To see him small and frail made me angry and tormented. I wanted to fight him for not fighting; I wanted to save him although he didn't really want to be saved.

All the firsts without him are numbing. I turned 55 without that morning phone call from him. I

planned my Christmas around his memory, recreating everything from my childhood I could, down to the icicles on the tree.

My favorite picture of him sits on my desk right in front of me. He is strong and young in a canoe wearing a red and black flannel shirt. I bought myself that same shirt, and I wear it like clockwork on Sundays.

The void is so big and consuming. My faith gives me depth during my busy days, but little can keep me from the pain on quiet evenings. My dog has become accustomed to the tears and glow of the fireplace as I wait for a sign that my dad is near. Just one more chance to talk to him is all I want.

Being optimistic and positive has always been second nature to me. I readily see the good in all things. I have weathered the cancer storm and divorce; my single parent status has been an honor.

A good friend shared with me her own stories of being "dad-sad." I know I am not alone. But today, for whatever reason, my dad is on my mind and in my heart and writing about it has eased the pain.




