End-of-the-year tax planning

AS WE PREPARE TO CELEBRATE Thanksgiving this month, we realize that the end of another year is just around the corner. This is the time to start thinking about end-of-the-year tax strategies and looking for ways to minimize your tax bill come April.

You pay your taxes with hard-earned money. Taxes can be complicated and stressful. Tax stress can even affect everyday activities, such as driving. In fact, according to 30 years of accumulated statistics by the National Highway Safety Administration, fatal car crashes increase a whopping 6% on April 15. Coincidence? I think not.

Unfortunately, when people are stressed, they may be capable of making mistakes on their tax returns. Employing some end-of-the-year tax-saving and planning strategies might not only help lower that stress, but also help you rest easier come tax filing time.

First, here are some strategies to employ between now and the end of the year:

I) Defer your income. Income is taxed in the year it's received, so why pay tax today if you can pay it tomorrow (or next

year) instead? Although it can be hard for some employees to postpone wage and salary income, you may be able to defer a year-end bonus into next year, if your company allows it.

If you are self-employed, you have more flexibility when it comes to timing of your income. You can defer billing until late December, for example, to ensure that payment won't be received until January.

Whether you are an employee or self-employed, you can also defer income by taking capital gains in 2020 instead of 2019. Of course, it only makes sense to defer income if you think you will be in the same or lower tax bracket next year.

2) Determine if you will have enough deductions to itemize or claim the standard deduction. With the increase in the standard deduction starting in 2018, the number of taxpayers that can itemize has dropped significantly, but itemizing remains a valuable option for a large number of taxpayers.

Generally speaking, all deductions need to occur within the taxable year to qualify for a current-year deduction. The exception to this rule can be contributions to your Traditional IRA or health plan, which can be made during a time frame in the following tax year, but usually not beyond the tax return due date, including extensions. *If* you are able to itemize your deductions, then point number 3 will apply to you.

3) Take some last minute tax deductions. Similar to deferring income to next year, you can also lower your tax bill by accelerating deductions into this year. For example, contributing to a charity (such as the WPFA Scholarship Foundation) is a great way to get a deduction--and you control the timing of the deduction.

• You can supercharge the tax benefits of your generosity by donating appreciated stock or property to your

favorite charity rather than cash.

• Better yet, as long as you've owned the asset for more than one year, you get a double tax benefit from the donation: you can deduct the property's fair market value on the date of the gift and avoid paying capital gains tax on the built-up appreciation.


• If you are making estimated payments for your state or local income taxes, consider making your fourth quarter estimated tax payment by Dec. 31.

Pay a property tax bill that is due early next year. Perhaps do the same with a doctor, dentist or hospital

bill.
 4) Look for all home office expenses. If you are self-employed or work from home as an independent contractor, accelerate as many expenses as you can afford to pay this year to bring down your taxable self-employment income.

5) Sell "loser" investments to offset any gains. A key year-end strategy is called "loss harvesting" --that is, selling investments such as stocks and mutual funds to realize a loss. You can then use those losses to offset any taxable gains you have realized during the year. Losses offset gains dollar-for-dollar. And, if your losses are more than your gains, you can use up to \$3,000 of excess losses to reduce other taxable income. If you have more than \$3,000 in excess losses, the loss can be carried over to next year to offset any gains or any other taxable income, and the loss can be carried forward year after year until it is used up for as long as you live!

6) Contribute the maximum to retirement accounts. Remember that bonus we were talking about deferring into next year? If it can't be deferred, maybe it can be used as a contribution to your 401(k) or Individual Retirement





Get a flu shot, but get the right one

IF YOU ARE 65 OR OLDER, the flu can be more dangerous for you than ever before. As you age, your immune system can become weaker, so just by aging you are at a higher risk. Even if you are in reasonably good health, you are at risk for catching the flu and developing related complications. In fact, an older person dies from flurelated illness every 12 minutes of every single day. Sixty percent of all hospitalized flu patients are over 65.

This is alarming information. If you are living with a chronic illness--like heart disease, diabetes, or COPD/asthma--you have an even higher chance of developing a serious complication that can result in death.

Your best defense, the experts say, is to get a flu shot annually and get it early in the season. I recently learned that there are options for senior flu shots. Make sure you have a conversation with your doctor or pharmacist so you receive the best flu shot option for you. Higher strength flu shots have been developed for people 65 and older.

If you are a caregiver, you should also ask for the strongest protection. Influenza is highly contagious for all age groups.

Be informed, ask questions and don't assume that every flu shot is the same. You are your own best advocate for healthy living.

Account. You have until the end of the year to make contributions to your 401(K), and until the tax filing deadline to fund your IRA account.

7) Check your IRA distributions. You *must* start taking minimum required distributions from your Traditional IRA by April 1 of the year following the year in which you turn age 70 ½. *But*, if you wait to take your first distribution in the year following the year in which you turn 70 ½, you will then be required to take *two* distributions that year, since the first one (by April 1) is deemed to be the prior years' distribution. Depending on your situation, this could be a good strategy. Consult your personal tax advisor for more information.

Failure to take the required minimum distribution triggers one of the largest IRS penalties: a 50% excise tax on the amount you should have withdrawn, but didn't. Your required minimum distribution is always based on the total value of your IRA at the beginning of the year, but can be withdrawn at any time during the year.

8) Review all tax credits. Be sure you are taking advantage of any and all tax credits for which you qualify, such as the Child Tax Credit, Child and Dependent Care Tax Credit, the Earned Income Tax Credit, Education Credits, and the Saver's Credit. The Saver's Credit (formerly known as the Retirement Savings Contribution Credit) is one of the most overlooked/underutilized tax credits and can help middle-income families reduce their tax bill dollar-for-dollar up to \$1,000 (\$2,000 if married filing jointly) if they are saving for retirement.

Now, here are some strategies that might help reduce your stress come tax time:

I) Start a file in January that contains all of your tax documents. This should include W2's, interest, mortgage, dividends and stock statements, etc. Keeping them all in one place will help you to be more organized when it comes time to prepare your returns or meet with your tax accountant.

2) Adjust your W4. If you are employed, now is the time to review your withholding and adjust your W4, if necessary. With the recent tax law changes, your withholding may not be enough now (meaning that you may have a tax bill due come April 15) or may be withholding too much (meaning that you'll get a larger refund come April).

3) Start reviewing your tax situation <u>early</u>. Don't wait until April 14 to get started on your returns. Even if you anticipate having a tax bill due this year, you're better off knowing the number as soon as possible, rather than waiting until the last minute. You don't want the added stress to impact your life and end up as a statistic like the one I mentioned in my opening paragraph.

As always, be sure to check with your personal tax advisor or CPA before making any changes or applying any of these strategies. While he or she can't give tax advice, your WPA agent can be counted on to help you make decisions regarding your life insurance, beneficiary designations, IRA accounts and minimum required distributions.

This is also the perfect time of the year to review your beneficiary designations and make sure they are up to date and comply with your current wishes. Don't have an agent? Call the Home Office, and we'll be happy to help.

Remembering a Hungarian Giant

This *Tibor's Take* is dedicated in memory of the Rev. Msgr. Dezső Török who recently passed away at age 96. Msgr. Török was a true American-Hungarian. He was born in Moson, Hungary, and ordained in Germany. In 1950, he arrived in Youngstown, Ohio, helping hundreds of Magyars settle in the area following World War II and assisting an influx of refugees following the 1956 Revolution. He was the spiritual leader for not only the members of St. Stephen of Hungary Church but also many other Hungarians in the Tri-State area. Msgr. Török's accomplishments were numerous. He was a strong voice against Communism and authored several religious prayer books and a memoir.


I have mentioned Msgr. Török many times over the years in various editions of Tibor's Take, both by name and anonymously. "Dezi," as he was often called by those who knew him best, was an inspiration to many and quietly supported many Hungarian groups and activities. Back in 1979, he urged my father and grandfather Cseh to continue to help broadcast the "Souvenirs of Hungary" radio program on WKTL. For 40-plus years, he silently supported and advised our endeavors as the radio show evolved. Using the name "Joska," he oftentimes sent greetings out to listeners with the intent of not revealing who the real person sending those dedications was. Msgr. Török suggested that our radio program should end each Saturday afternoon with the playing of the Magyar *Himnuz*. This is a tradition we continue every broadcast.



Strength in unity A review of the Association's 39th General Convention

PITTSBURGH -- William Penn Association, the nation's only Hungarian fraternal benefit society, held its 39th General Convention Oct. 12 to 14 at the DoubleTree by Hilton Hotel Pittsburgh - Green Tree.

During the three-day meeting, the 80 elected and ex-officio delegates attending the Convention adopted revisions to the Association's By-Laws, elected nine members to the Board of Directors, welcomed a new Chair of the Board and two new National Officers, and raised thousands of dollars for WPA's scholarship foundation.

The Convention's schedule of events began Saturday, Oct. 12, with delegate registration and the opening of the delegate hospitality suite. After receiving their credentials and welcoming gifts at registration, many delegates and their guests visited the hospitality suite, where they could enjoy hors d'oeuvres, Hungarian pastries and soft drinks while meeting their fellow delegates, renewing old friendships and making new friends.

Later that evening, members of the Credentials, Resolutions and Nominating Committees met separately to lay the groundwork for the remainder of the Convention.

The Convention was officially called to order Sunday, Oct. 13, by Andrew W. McNelis, Chair of the WPA Board of Directors and Chair of the Convention. He introduced members of the Marine Corps League-South Hills Detachment #726 Pittsburgh, who presented the flags of the United States of America and Hungary. In a united display of patriotism, all in attendance joined in reciting the Pledge of Allegiance, then singing "The Star-Spangled Banner," led by Home Office employee Brittany Kellar.

Chair McNelis then welcomed the Rev. John P. McKinsey Jr., a delegate from Branch 352 Coraopolis, Pa., to the podium to offer the invocation.

The meeting's opening session featured greetings

from National President George S. (Pete) Charles Jr.

He praised the members of the WPA for their hard work, loyalty and dedication which have helped the WPA to not only survive but also thrive during its 133 year history. He noted many challenges lay ahead for the Association, but concluded those challenges could be met successfully with the continued loyalty and support of our members.

National Vice President-Treasurer Diane M. Torma extended greetings to the delegates and offered a brief review of the financial strength of the WPA.

In yet another show of unity, the Convention elected by unanimous ballot both the Board of Directors and Alternate Directors.

Reelected to the Board were: Michael J. Chobody of Branch 88 Rural Valley, Pa.; David M. Kozak of Branch 8 Johnstown, Pa.; Debra A. Lewis of Branch 129 Columbus, Ohio; Andrew W. McNelis of Branch 34 Pittsburgh, Pa.; Joyce E. Nicholson of Branch 349 Weirton, W.Va. ; Katherine E. Novak of Branch 28 Youngstown, Ohio; James W. Robertson of Branch 336 Harrisburg, Pa.; Richard E. Sarosi of Branch 14 Cleveland, Ohio; and Anne Marie Schmidt of Branch 249 Dayton, Ohio.

The new Board was sworn into office by the WPA's General Counsel, Ralph F. Manning.

The new Board later met in a special session during which it elected Katherine E. Novak as Chair of the Board, and Andrew W. McNelis and Anne Marie Schmidt as Vice Chairs. The Board also reelected Mr. Charles as National President and Mrs. Torma as National Vice President-Treasurer. It also elected two longtime Home Office employees as National Officers: Cassandra Holmes as National Vice President-Secretary and Steven F. Charles as National Vice President-Internal Operations.

Manning, Esq., a gold plaque in the shape of an eagle honoring Mr. McNelis, which will be mounted next to the WPA's Tree of Knowledge at the

Home Office. Then, President Charles and the National Officers unveiled a portrait of Mr. McNelis which will hang with other past leaders of the Association in the Home Office.

The delegates also took time to remember the distinguished members and friends of the WPA who had passed away since the last Convention in 2015. The Rev. Joseph G. Bodnar, a delegate from Branch 19 New Brunswick, N.J., led the service.

Throughout the Convention, delegates were unified in their support of the William Penn Fraternal Association Scholarship Foundation, which provides grants to young members seeking a higher education. Over the three days of the Convention, a total of \$23,735 was raised for the Scholarship Foundation. More than half of that total (\$12,040) came in the form of donations and pledges. The remainder was raised through the sale of ads for the Convention souvenir program book (\$9,825) and proceeds from the Convention raffle (\$1,870).

Delegates also heard from several speakers who shared important information with the Convention delegates, including:

• Leo A. Hannah, CPA, partner with H2R CPA, who offered highlights of the WPA's financial standing; and

• WPA General Counsel Ralph F. Manning, who led the delegates in a review of the Association's proposed bylaws. After reviewing the by-laws, the Convention unanimously adopted them.

By Monday afternoon the Convention had adjourned with all eager to resume the work necessary to help WPA not only survive but thrive in the years ahead. \Box


Third Prize - \$200

Eligibility Rules for Year 2020 Scholarship Grants

The Board of Directors has established the following rules governing eligibility for scholarship recipients:

a) The student applying for a scholarship grant must be an individual life benefit member of William Penn Association in good standing for four (4) years as of January I, 2020.

f) **NEW Applicants** must submit the following:

I. An Essay of <u>100 words or fewer</u> answering the question: "If you were an inventor, what would you invent?" If the essay exceeds 100 words or is on the incorrect topic, the application will not be accepted.

The Scholarship Application and Essay must be mailed and postmarked by Friday, May 29, 2020. We recommend the student applicant submit these materials via Certified Mail to ascertain proof of mailing date. **NEW APPLICANTS**

2. A copy of the student applicant's latest scholastic record. All renewal applicants **must maintain a cumulative Grade Point Average of at least 2.5 on a 4.0 scale to qualify.**

3. Proof of enrollment for the Fall 2020 school term.

Items 2 and 3 must be mailed and postmarked by Monday, August 31, 2020.

h) All applications and essays must be submitted and signed by the student applicant requesting the grant and mailed to the attention of the President. Eligibility rules for renewal grants will be in accordance with the eligibility rules in effect for the initial grant. Materials submitted by anyone other than the student applicant will not be considered. **E-mailed and faxed submissions will NOT be accepted.** Any applications and essays postmarked after **Friday, May 29, 2020** will not be considered.

i) Scholarship grants will be awarded by the Executive Committee of the William Penn Fraternal Association Scholarship Foundation, Inc., once each year. <u>Grants will be paid directly to the student applicant provided the student applicant is a life</u> <u>benefit member in good standing on the date the check is issued and all of the eligibility requirements stated herein have</u> <u>been met.</u>

j) If for any reason the recipient does not attend college after receiving the grant, it must be returned to the William Penn Fraternal Association Scholarship Foundation, Inc.

k) In compliance with current privacy laws, all information regarding scholarship status will be divulged only to the student applicant and to the parents and/or legal guardians of the applicant.

Cultural Garden hosts gala organ concert

BRATENAHL, OH -- The Cleveland Hungarian Cultural Garden held its 4th Gala Annual Organ Concert Oct. 6 at the home of Dr. Eugene and Janet Blackstone in Bratenahl, overlooking Lake Erie.

The guests were there to hear one of the largest residential organs in the U.S., with 7,406 pipes, 137 ranks and 10 electromechanical bell voices. The organ was designed by Hungarian Richard Fleischman, who also designed the 9,000 sq. ft. home around the organ as a piece of art and an instrument.

The program featured organist Rodney Barbour of Cincinnati (*pictured right*), performing "Bell Prelude" by Joseph Clokey, a melody from "The Merry Widow" by Franz Lehár, the "Coronation March" by Giacomo Meyerbeer and works by Leonard Bernstein and Antonio Vivaldi.

The program also included violinist Emma Shook and bassist Henry Peyrebrune, both of the Cleveland Orchestra, and Alexander Fedoriouk on the cimbalom (*pictured below*). The musical selections included "Csárdás" by Vittorio Monti, Hungarian Dances #5 by Brahms and a selection of Hungarian folk tunes, much to the delight of the enthusiastic crowd.

At the post-performance reception, guests enjoyed the cuisine of Hungary, including Hungarian pastries.

The Hungarian Cultural Garden was dedi-

cated in 1938 and is one of 31 nationality gardens in the Federation of Culture Gardens. The history of the gardens dates back nearly 100 years. Many famous architects and designers have had a part in developing the gardens.

Proceeds from the organ concert benefit the Hungarian Cultural Garden Maintenance Endowment which will guarantee that the Hungarian Cultural Garden will remain as beautiful as it is today for future generations. - Brown construction paper
- Scissors
- Paint brush
- Electric tea light
- Wet paper towel

What You Do

- With the paint brush, cover a small section outside of a Mason jar with Mod Podge®.
- Place one of the ripped up pieces of tissue paper onto the glued section.
- Repeat the first two steps until the entire jar is covered with different colors of tissue paper. Use a wet paper towel between applying the tissue paper pieces so that your hands don't get too sticky from the Mod Podge[®] and begin sticking to the tissues.
- When you're done adding the tissue paper, cut a tree trunk and tree limbs out of the brown paper with scissors.
- Create the tree by using more Mod Podge[®] and applying the tree trunk and limbs.
