hen a loved one passes away, locating a life insurance policy can be a challenging but necessary task. There are some steps you can take to get the information you need. Here are a few tips to guide your search.

# Search the deceased's documents & correspondence

In many cases, evidence of a policy and any relevant information can be found in your loved one's personal and financial documents and correspondence.

- Search through paper and digital files, bank safe deposit boxes, and other storage spaces for insurance-related documents.
- Check bank statements for checks or automatic drafts to life insurance companies.
- Check the deceased's mail and email for premium or dividend notices. If policy payments are up-to-date, there will be no notice of premium payments due; however, the company may still send an annual notice regarding the status of the policy or statement of a dividend.
- Review the deceased's tax returns for the past two years for a record of interest income or expenses paid to life insurance companies. Life insurance companies pay interest on accumulations on permanent policies and chart interest on policy loans.
- Check the application for each life insurance policy you find. This document, typically attached to the policy, will have a list of any other life insurance policies owned at the time of the application.
  - Talk to the deceased's banker, financial adviser, and attorney.

If this search turns up empty, there are still actions you can take.

# Submit a request to the NAIC Life Insurance Policy Locator Service

The National Association of Insurance Commissioners (NAIC) Life Insurance Policy Locator Service, a free online tool, can assist you in locating life insurance policies. Once a request is received, the NAIC will ask participating companies to search their records to determine whether they have a life insurance policy in the name of the deceased you entered. If they do, the participating company will respond to you if you are the designated beneficiary or are authorized to receive the information.

Log onto https://eapps.naic.org/life-policy-locator/#/welcome and follow the prompts. You will need information from the death certificate, including social security number, legal first and last name, date of birth, and date of death. # Contact the state's unclaimed property office

When a life insurance company is aware that an insured client has died but cannot find the beneficiary, the company must turn the death benefit over to the state where the policy was purchased as "unclaimed property."

If you know (or can guess) the state where the policy was bought, you can search the state's unclaimed property database. The National Association of Unclaimed Property Administrators has a search tool that will take you to your state's unclaimed property database. To use this tool, log onto <a href="https://unclaimed.org/search/">https://unclaimed.org/search/</a>.



# Be aware of special challenges

There may be circumstances that complicate the search for a loved one's life insurance policy:

- The insurance company changed its name or sold the policy to another company. The NAIC provides tips on finding insurance companies that have changed their names, merged with other insurance companies, or sold blocks of policies to other insurance companies. You can find these tips at <a href="https://content.naic.org/consumer\_life\_co\_locator.htm">https://content.naic.org/consumer\_life\_co\_locator.htm</a>.
- The company went bankrupt. Contact the state life and health guaranty association. The National Organization of Life & Health Insurance Guaranty Associations has a search tool to find your state guaranty association. Guaranty associations provide a safety net for their state's policyholders, ensuring continued coverage up to the limits outlined in state law. • The policy may have been purchased in Canada. Reach out to the Canadian Ombudservice for Life and Health Insurance for information at https://olhi.ca/insurance/search-for-lost-policy/.

# Keep in mind fee-based services are available if needed

Sometimes, even despite all the best efforts, finding an insurance policy when a loved one has passed away can seem overwhelming. In these cases, it is helpful to know that MIB, an insurance membership corporation, offers services for a fee. This service may be able to find evidence of life insurance applications but does not indicate whether a life insurance policy was purchased. You can find this service by logging onto <a href="https://www.mib.com/fee based services.html">https://www.mib.com/fee based services.html</a>.

Additionally, several private companies can assist you with the search for a lost life insurance policy for a fee.

# In the Kitchen with Chef Béla



# Gone fishing

He is a member of the American Culinary Federation, a Master BBQ Cook, and judge of the Kansas City Barbeque Society. ow that winter is behind us, and we are getting closer to the warmer weather, if you are like me, you will enjoy the pleasure of going fishing to catch fresh fish for dinner. Let me share some basic information about the fish we eat and what is available...and, of course, a few recipes on how to prepare your freshly-caught bounty for you and your family.

The term "fish" includes both *freshwater* and *saltwater* species. Some freshwater species include trout, pickerel, walleye, catfish and bass both largemouth and smallmouth. Saltwater species include salmon, haddock, halibut, whiting, swordfish, shark tuna and mahi-mahi.

Fish can also be described as either *round* or *flat*. Round fish swim in a vertical position and have eyes on both sides of their head. Flat fish have an asymmetrical compressed body and swim in a horizontal position and have both eyes on the top of their head. The most popular round fish are trout, bass, salmon, cod, and grouper. Flat fish that are most common to the consumer are flounder, sole, halibut and turbot. Both types can be purchased at any local fish market or food store.

We can even break down fish not only by species but also by the way the fish is produced. *Wild* fish are caught in the ocean or freshwater lakes or streams, have a stronger flavor and a more solid body as they must fend for themselves against predator fish and hunt for their food. Their filets are thinner, usually darker in color or snow white, but easier to prepare. *Farm-raised* fish have a softer texture with a buttery, not strong wild flavor with thicker filets.

Is one type better than the other? Both have their benefits nutritionally and to the environment as well. Fish farming provides a constant supply that can be controlled and is more readily available than wild, but the overall flavor is determined by what the fish is fed at the fish farm. Wild fishing does not guarantee that enough fish can be caught but the product is healthier, more nutritious and stronger bodied.

Keeping all of this in mind, eating fish provides vitamins, minerals, iodine and healthy omega-3 fatty acids in your diet. Preparing fish is an easy and delicious way to provide a healthy meal for your family.

One of the most common negative comments I hear about fish is that it is too mushy or soft. That happens when you overcook the fish. To prevent this, remember that, when cooking fish, translucent flesh becomes opaque or solid in color and very firm. As a fish cooks, the fleshy part of the fish easily separates from the bones. And finally, the flesh or meaty part of the fish begins to flake. If you follow the above tips and test your fish for doneness, you will always cook fish the proper way.

Remember, also, that the body and fleshy part of a fish does not have as much connective tissue as a piece of meat, hence it will take less time to cook.

And, don't forget about residual heat and carryover cooking: anything heated up will continue to cook after the product is taken off the stovetop or out of the oven. It takes practice, but as you cook more proteins, including fish, you will know when to take the food away from the heat and let it continue to firm up properly. Most recipes will give you very precise instructions on how to prepare the protein you are cooking.

Speaking of which, the most popular ways to prepare fish are frying, baking, and broiling--all dry heat methods. You can also prepare fish by wet methods such as chowders, stews and casseroles.

Fish are a great all-around protein source to prepare and enjoy. I have chosen recipes that use a few various cooking techniques. So, let us get into the kitchen and start cooking!



# **Baked Fish**

¼ stick butter

¼ cup white wine

1 cup Swiss cheese, grated

1 pound fish filets, your choice of fish

½ cup bread crumbs

½ teaspoon garlic powder

½ teaspoon sweet paprika

1 teaspoon fresh parsley, chopped

Salt & pepper, to taste

In a long baking dish, put the butter and wine. Place in a 400°F oven to melt the butter. Lay the fish filets in the baking dish, covering the entire dish.

In a small bowl, mix the cheese, breadcrumbs, garlic, paprika and parsley, then sprinkle on top of the filets.

Bake for 10 minutes or until the fish flakes apart with a fork. Season the fish with salt and pepper before serving on a platter to your guests.

# **Pan Fried Fish**

4 fish filets, your choice of fish ½ cup oil, vegetable or canola ½ cup all-purpose flour 2 teaspoons paprika Salt & pepper, to taste

Pat the filets dry with a paper towel, then season the fish with salt and pepper.

Mix the flour and paprika on a plate then coat all the filets on both sides pressing down to coat then shake to remove excess.

Put the oil in a skillet over

medium/high heat until the oil becomes thin in the pan, about 30 seconds. Add the fish and cook for 3 minutes, then flip over and cook the other side for another 2 minutes until the fish is firm and opaque.

Remove from the skillet and serve hot to your guests with lemon wedges and tartar sauce.

# Fish Chowder

1 large onion, chopped

½ cup butter, cut into cubes

4 cups water

6 cups potatoes, peeled & cubed 2 pounds codfish filets, cut into

large chunks

3 tablespoons lemon juice

2 cups milk

2 cans (12 ounces each)

evaporated milk

2½ teaspoons salt

2 teaspoons pepper Fresh parsley, chopped

In a Dutch oven or heavy stovetop skillet, add the butter and onion and sauté until translucent. Add the water and bring to a boil, then add the potatoes and cook for 10 minutes.

Add the fish with the lemon juice, reduce the heat to low and simmer for 10 minutes.

When the fish becomes solid and opaque, add the milk and evaporated milk, then season to taste with salt and pepper.

Garnish with parsley and serve hot to your guests.



# **Creamy Fish Casserole**

2 pounds white filets, any type fish

2 tablespoons olive oil ½ cup onion, finely chopped 2 garlic cloves, minced 1½ cups tomato juice 1 can (12 ounces) evaporated

1 tablespoon cornstarch 2 tablespoons lemon juice 2 teaspoons lemon zest Salt & black pepper, to taste Fresh parsley, chopped



Preheat the oven to 425°F.

Dry the filets with a paper towel, then season on both sides with salt and pepper.

Heat the oil in a skillet over medium heat, then add the onions and cook for 3 minutes until they are translucent. Add the garlic and cook another minute; keep stirring so you do not burn the garlic.

Add the tomato juice, evaporated milk, cornstarch, lemon juice and lemon zest, mixing to combine all and cook for 5 minutes until the sauce thickens.

Place the filets over the sauce, then bake in the oven for 15 to 20 minutes until the fish flakes when tested with a fork.

Sprinkle with parsley for garnish, then serve hot to your guests.

# Actuary's Report for 2023

**William Penn Association** has continued its long history of outstanding service to members while maintaining a strong margin of financial safety, maintaining strict governance guidelines, and its commitment to honoring its members' guaranteed benefit contracts.

The financial reports to the regulatory authorities and the actuarial report to the Officers and Directors are summarized for the benefit of the members. All numbers within this publication are taken from the official reports as filed and have been rounded for convenience.

The Association's controlled growth surplus and development continued in 2023. This approach was rewarded with profits in all major lines of business totaling \$4.3 million. However, largely because of higher surrenders driven by sharply higher interest rates, asset positions decreased by 7.8%. Profitability continues to be driven by careful management of investments, favorable persistency, prudent control of expenses, and favorable mortality experience.

This solid financial performance is sufficient to sustain fraternal activities. The members should continue to feel proud of WPA and the financial strength and discipline that underpin their guaranteed benefits.

WPA's financial strength should be emphasized. In its history, no WPA member suffered any loss in benefit value or reduction in dividends nor experienced a rate increase because of market fluctuations. WPA continues to be a very safe, secure place to hold money for future distributions and benefits.

The Association assets total over \$524,000,000, and their quality remains high, with \$484,600,000

(97.8%) of the bonds held being investment grade. All members can continue to have confidence that the assets standing behind their policies are sound and will provide the required funds when needed.

The margin of safety on December 31, 2023, continued at a high level of 113.15%. This means that the Association held over \$113.15 of admissible assets behind each \$100 of liabilities as a safeguard to all members that promised member benefits will be paid when due. The Association's safety margin is comparable to that of other fraternal benefit societies.

The Association enjoyed a very favorable year from investments. The net rate of return on mean assets was 4.87%, which is strong, considering the persistent low interest rate environment from which we have recently emerged. These strong returns support the competitive rates paid to members. During 2023, the Association earned net investment income of \$25,798,000 after deducting all investment expenses. Investment income exceeded requirements by \$9,121,000 in 2023. Excess interest continued to be the most important profit source to the Association.

In addition to the excellent investment returns, it is worth noting that the Association maintains Security Valuation Reserves of \$11,381,000 to guard against adverse fluctuation in investments.

The Association has \$460 million set aside to cover its life insurance and annuity liabilities, as well as member deposits and future claim payments. These insurance liabilities are computed according to the prudent and conservative standards of the Commonwealth of Pennsylvania.

During 2023 the Association paid out \$99,501,000 to members. A breakdown of these payments over the past five years is presented below:

# **WPA** continues to provide reliable financial resources to its members.

In our opinion, the amounts carried in the balance sheets on account of the various actuarial items:

- (1) are computed in accordance with commonly accepted actuarial standards consistently applied and are fairly stated in accordance with sound actuarial principles;
- (2) are based on actuarial assumptions which produce reserves at least as great as those called for in any contract provision as to reserve basis and method, and are in accordance with all other contract provisions;
- (3) meet the requirements of the insurance law and regulations of the Commonwealth of Pennsylvania and are at least as great as the minimum aggregate amounts required by the state in which this statement is filed;
- (4) are computed on the basis of assumptions consistent with those used in computing the corresponding items in the annual statement of the preceding year end with any exceptions as noted below; and
- (5) include provision for all actuarial reserves and related statement items which ought to be established.

It is apparent that the officers and directors continue the skillful management of the members' money while maintaining very strong safeguards.

# Eligibility Rules for Year 2024-2025 Scholarship Grants

The Board of Directors has established the following rules governing eligibility for scholarship recipients:

- a) The student applying for a scholarship grant must be an individual life benefit member of William Penn Association in good standing for four (4) years as of January 1, 2024.
- b) Scholarship grants are awarded to full-time undergraduate students only if they are accepted by or are currently attending an accredited college, university, school of nursing, technical or trade school.
- c) Grants are awarded based on the student's plan of insurance:
  - Applicants with the Special Juvenile Term to Age 25 plan are eligible for a ONE-TIME \$500 grant, OR
  - Applicants with any Whole Life plan with a \$5,000 minimum face amount are eligible for a ONE-TIME \$2,000 grant.
  - Conversion from the Juvenile Term plan to a Whole Life plan is permitted to be eligible for the larger grant. This must be completed before submitting your scholarship application.
- d) All applicants must complete and submit the WPFA Scholarship Foundation, Inc. Application for Scholarship Grant, which can be found in this issue of *William Penn Life*. An application also may be obtained by writing to: WPFA Scholarship Foundation, Inc., 709 Brighton Road, Pittsburgh, PA 15233 or may be downloaded from the Association's website at *www.wpalife.org*.
- e) All Applicants must complete ONE (1) of the following requirements:
  - Submit a one-time essay on a topic that is meaningful to you, limited to between 150-200 words.
  - Either attend a current WPA branch event/project, which must be approved and verified by a Branch Officer, **OR** participate in a current community service project, proof of which must be detailed and verified by the Event Coordinator. Such verification from either the Branch Officer or Event Coordinator must be submitted by the student to the WPA Home Office by the application deadline date. You may also submit a photograph of your participation for publication in *William Penn Life*.
  - Write an article for publication in William Penn Life, approved at the Editor's discretion.
- f) All applications, essays, documents and articles must be signed and dated by the student applicant and submitted either via the U.S. Postal Service to the WPFA Scholarship Foundation, Inc. at the address listed in section (d) above, OR via email to <a href="mailto:scholarship@wpalife.org">scholarship@wpalife.org</a>, OR via fax to 412-231-8535. Materials submitted by anyone other than the student applicant will not be considered. All applications, essays, articles and other documents (excluding proof of enrollment) must be postmarked, emailed or faxed by Friday, May 31, 2024. Items postmarked, emailed or faxed after that date will not be considered.
- g) All applicants must submit proof of enrollment for the Fall 2024 academic term. Such proof of enrollment must be mailed and postmarked, emailed or faxed to the WPA Home Office by **Friday, August 30, 2024**.
- h) Scholarship grants will be awarded to the applicant by the Executive Committee of the WPFA Scholarship Foundation, Inc. on a one-time basis. *Grants will be paid directly to the student applicant provided the student applicant is a life benefit member in good standing on the date the check is issued, and all the eligibility requirements stated herein have been met.*
- i) If for any reason the recipient does not attend the school after receiving the grant, it must be returned to the WPFA Scholarship Foundation, Inc.
- j) In compliance with current privacy laws, all information regarding scholarship status will be divulged only to the student applicant and to the parents and/or legal guardians of the applicant.

- Use a foam brush to paint on stems and leaves.
- Glue the pom poms or other chosen material in the center of each flower. If you don't want the 3-D look, use a contrasting color of paint.

He also developed many other vital safety innovations, including the collapsible steering column.

Barényi was inducted into the Detroit Automotive Hall of Fame in 1994 and nominated for Car Engineer of the Century in 1999. Unfortunately, Barényi didn't see this nomination as he died in 1997.




